This year the Student Scholarship Organization (SSO) can be a benefit to the entire ministry of NGCS. As the economy continues to be a concern, SSO financial aid will help provide operating costs by funding tuition costs for qualifying students. Using your dollars for tuition instead of state taxes will help fund the Biblically-based education provided at NGCS.

BILL HB 1133

Receive a Georgia state tax credit by designating your tax dollars to **North Georgia Christian School**. It is important that you receive your preapproval form and send your check before the \$50 million limit set by the state is reached.

Annual taxpayer limits are:

\$2,500	Married filing jointly
\$1,250	Married filing separately
\$1,000	Single
75%	of state tax liability for "C" Corp.

Easy Pay Solution

If writing a large check at the end of the year is difficult, here is a solution. Do the following:

- Check with your CPA or look on your tax return to see what your tax liability was last year
- Divide that amount by 12
- Start a direct deposit savings account
- Reduce your deductions through your payroll
- Point the money you would have paid for taxes to the savings account
- Use the money in your savings for SSO

Contribution Time-frames

Donors may contribute on their own schedule as often as monthly if you choose. Follow the same process.

SSO Process Checklist

Part 1

1. Complete Georgia Form IY-QEE-TP1
 - a. Section A1, enter the amount of your contribution
 - b. Section C, date and sign
2. Mail the completed form to:

3. The Department of Revenue will mail your approval letter in about 2 weeks.

Part 2

1. Receive approval form from Department of Revenue. You have 30 days or until December 31st, whichever comes first, to complete these steps.
2. Make a copy for your records
3. Write a check to **Georgia Student Scholarship Organization Inc.**
 - a. In the amount you contributed on line A1 of IT-QEE-TP1
 - b. Write North Georgia Christian School in memo section
4. Fill out the attached Note
 - a. Name
 - b. Check number
5. Mail the following:
 - a. Pre-approval form
 - b. Check
 - c. Note
